The First President of India

Dr. Rajendra Prasad (1884–1963) affectionately addressed as ‘Rajen Babu’, was the First President of independent India from 1950 to 1962, navigating the nation through its formative years. Dr. Rajendra Prasad was a renowned freedom fighter, an eminent jurist, an eloquent Parliamentarian, an able administrator, a statesman par excellence, and above all, a humanitarian to the core. Dr. Prasad's legacy endures through his multifaceted contributions, reflecting the values of integrity, statesmanship, and a commitment to social welfare that continue to inspire generations in the journey of a vibrant, democratic India.

Dr. Rajendra Prasad, a doctorate from Allahabad University, initially practiced law at different High Courts. Mahatma Gandhi enlisted his support in 1917 for a campaign aimed at improving the plight of peasants exploited by British indigo planters in Bihar. In 1920, Dr. Prasad abandoned his legal career to join the non-cooperation movement.

Transitioning into journalism, he actively wrote for the nationalist cause, contributing to English publications like ‘Searchlight’ and founding and editing the Hindi weekly Desh (“Country”). Dr. Prasad faced multiple incarcerations by the British authorities due to his non-cooperation activities, with a significant period spent in jail from August 1942 to June 1945. He played a pivotal role in shaping the Indian Constitution as President of Constitution Committee and was one of the chief architects of Modern India.

Program Offered...

Undergraduate Five-year Integrated B.A. LL.B. (Hons.) Degree Programme

Dr Rajendra Prasad National Law University, Prayagraj offers undergraduate five-year integrated B.A. LL.B. (Hons.) degree programme. It comprises of ten semesters. Each academic year having two semesters prescribes six subjects for study in each semester. Semesters I to IV have a combination of subjects from liberal arts and the law. Twenty eight Compulsory Law Papers are offered as per the requirement of Bar Council of India. Out of these, four are Clinical Legal Education (CLE) papers. From VII semester onwards students are required to choose one honours stream offered by the University and thus will study eight courses under the chosen stream of specialisation.

The University is planning to offer Honours Courses in Constitutional Law, Environmental Law, Artificial Intelligence Law, International Law, Criminal Law, IPR etc. The option of Elective Subjects will also be available to students from VII Semester onwards. The students will be able to choose six elective courses from the list provided by the university that may include papers on Technology Law, Entertainment and Media Law; Energy Law, Water Law, Biodiversity Law, Healthcare and Bioethics Law; Sports Law, Gender and Law, Child and Law, International Human Rights, International Criminal Law, Investment Law, Taxation Law, Animal Rights, Criminology and Victimology, Forensic Science, Law and Economics, Applied Economics and Finance, Advanced Labour Law, Corporate Governance and CSR and host of other subjects as per the requirement of students and availability of experts.

1. National Law University, Prayagraj is situated in district Prayagraj, Uttar Pradesh.
2. Total area available for construction of building and other Facilities is 96183.68 square mtr. Or 23.76 acre.
3. Architect and consultancy work has been assigned to Mothers pride international private limited company.
4. Architect and design of the university is based on National law university Bangalore and National law university, Hyderabad.
5. Total number of students in the university will be 1250.
6. Key elements and features of the Proposed Buildings
7. Whole structure will be Earthquake resistant RCC structure.
8. Whole Campus will have one large gated entrance and exit.
9. Academic Building will have large façade, one porch in front and GRC, Stone cladding work on the walls of the academic building. Academic and administrative building will combinely have 6 entrances.
10. Academic and administrative building will be G+4 structure. On the ground floor 2 Moot court , dean office, Confrence hall , Auditorium and VIP rooms will be there on the first floor auditorium, conference hall , professor, associate professor and assistant professor chambers total 20 chambers and 12 chambers for the research scholars will be there. Auditorium library, lecture rooms, faculty rooms will be there on the second floor.
11. Estimate of Rs. 336.33 cr has been sanctioned for construction of National law university and a budget of 100 Cr. Has been allotted for financial year 2024-25 by the government.
12. Structure of the building will be designed by the EPC Contractor as it is a EPC project being costing more than 50 Cr and thereafter contractor will get the design verified by any renowned institute like IIT and NIT.
13. University will have separate indoor sports complex and outdoor sports stadium for the students.
14. One mini market centre will also be there for faculties and students residing in the university.
15. One large auditorium with a capacity of 1300 persons ,a G+3 structure will be there
16. The campus will have facility of Rain water harvesting, ground water recharge ,waste water recycling.
17. 50% of the terrace area will be used for solar panel which will generate a capacity of 465 Kw 16.3% of electricity generated by these solar panels will be connected to the main grid.
18. Low energy consumption lighting fixtures energy efficiency in HVAC will be achieved in all the buildings.
19. Multicoloured bins for biomedical waste, plastic waste, wet waste and dry waste will be installed in various locations of the campus for efficient collection and disposal of solid waste .
20. Lightweight AAC blocks will be used in the masonry of the building in place of conventional red bricks which will help in achieving Green rating for the building and at the same time reducing the weight of the structure.
21. All the internal roads of the campus will be cement concrete.

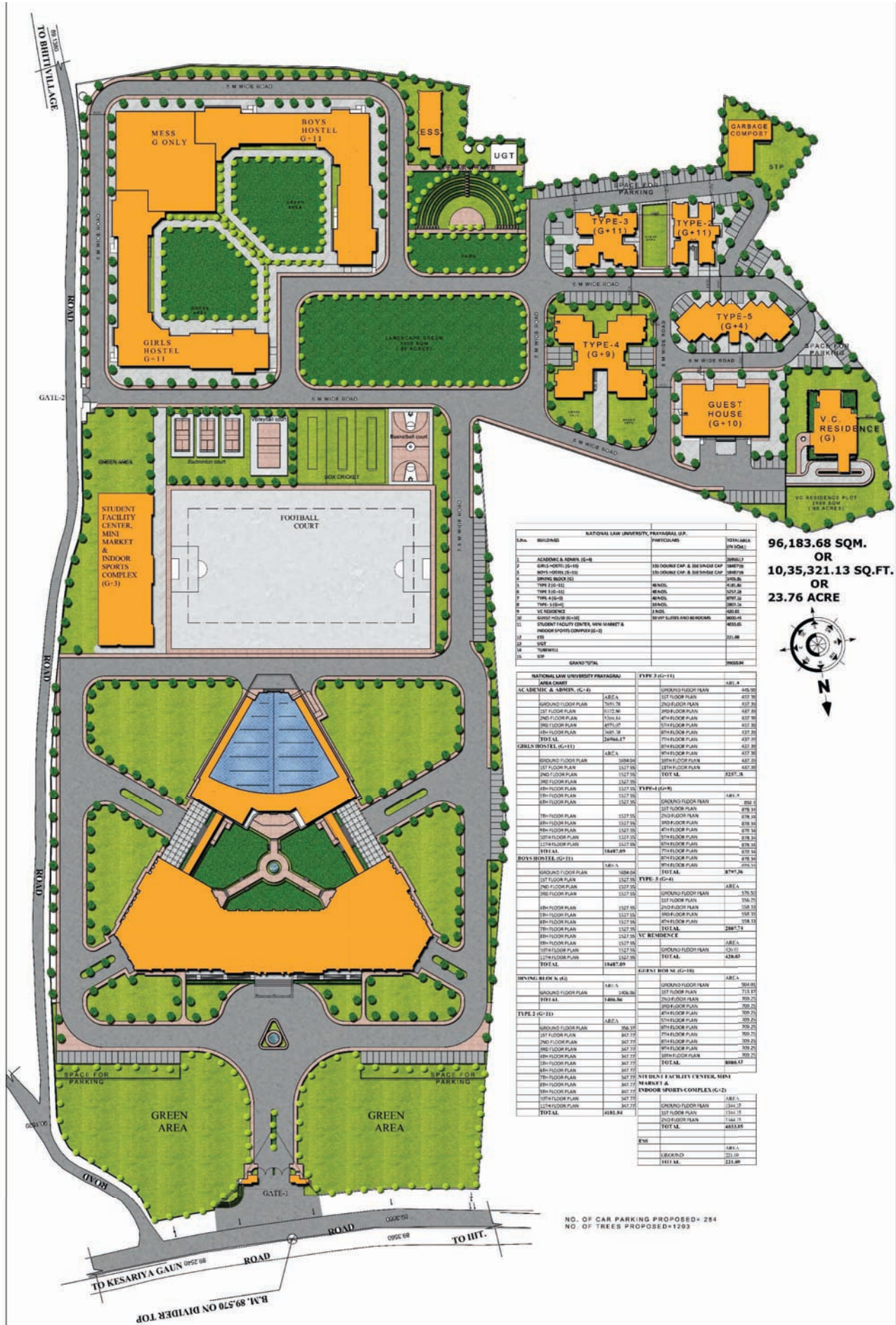
