While grounded in the study of law, these discussions are designed to transcend disciplinary boundaries—inviting perspectives from sociology, technology, politics, and international affairs—to reflect how law constantly interacts with and responds to the broader forces shaping our world. This interdisciplinary approach encourages students to see the law not as a static rulebook but as a dynamic force that interacts with every domain of public life. By creating a space for informed discussions, the initiative pushes students to move beyond passive learning and become intellectually engaged participants in civic life. Held every Thursday, the initiative urges the students to transition from the theoretical learnings of the day into the critical and analytical discourse and it is expected to benefit the students on an academic and personal level nurturing their public speaking and collaborative dialogue : skills indispensable for their career paths.

Most importantly, this will provide students a stage to question and understand the dynamic nature of law as it changes through the course of time. By encouraging students to speak, question, and respectfully disagree, it offers a unique platform where students are not mere observers but active contributors to knowledge.
